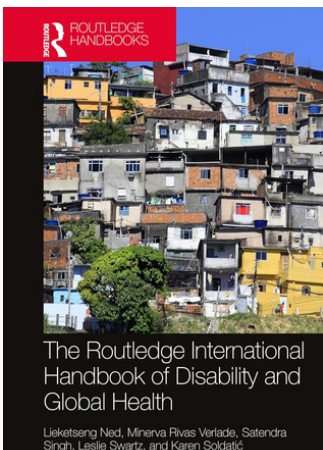

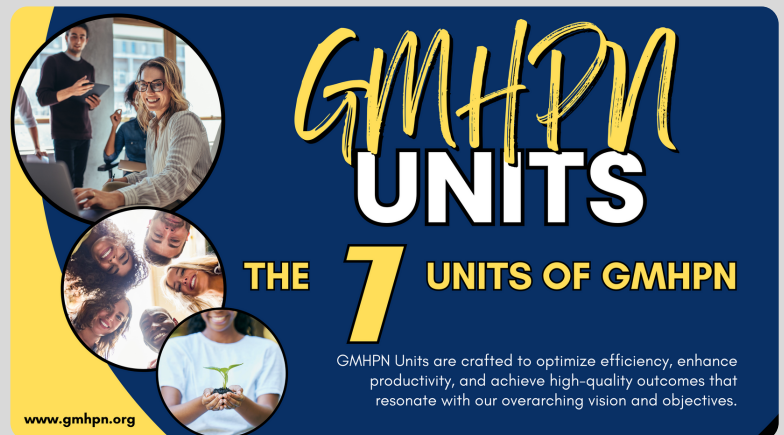
Young Agents 4 Change

Exciting Development

Global Mental Health Peer Network (GMHPN), supported by Kokoro and Vitol Foundation, in collaboration with a Global Mental Health Economist, are undertaking the development of a sophisticated, evidence-based costing model to support equitable remuneration for lived experience expertise provided to a range of global stakeholders and sectors with interests in the area of mental health. The aim of the project is to derive a fair, reasonable and standardised model to inform global remuneration practices for lived experience expertise, reflecting the range of services and consultancy roles that are increasingly necessitated in global health and development. This model will seek to account for diverse contexts and the complexity of expertise required in relation to the authentic involvement of experts by experience in mental health.
